

School Parent and Family Engagement Policy Cartersville Elementary School 2024-2025

In support of strengthening student academic achievement, Cartersville Elementary School (CES) receives Title I, Part A funds. - (B) Parents are encouraged to be actively involved in their child's education at school.
- (C) Parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child.
- (D) Other activities are carried out, such as those described in Section 1116 of the ESSA.

DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT REQUIRED SCHOOL PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS

JOINTLY DEVELOPED

Cartersville Elementary School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs. This will include opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Cartersville Elementary School parents are invited February 2025 to review and revise the school district and school family engagement policies; as well as the school wide plan and our school-parent compacts for the 25-26 school year. Parents/stakeholders were invited to attend the Comprehensive LEA Improvement Plan (CLIP) meeting on June 5, 2024 providing input for the 24-25 school year. These documents were presented to, discussed with CES' School Governance Council for review, and the CES school staff.

Cartersville Elementary School will hold a Parent Engagement event in Spring 2025, with opportunities for Open Discussion and Input for family members and community stakeholders regarding the school wide plan; parent and family engagement policy and school-parent compacts. This opportunity to provide input will be communicated to parents in a variety of ways including: posts on school websites, social media, automated phone calls, and flyers sent home with students. School Administration and Staff will also have opportunities to give their input on these important documents.

ANNUAL TITLE I MEETING

Cartersville Elementary School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents to attend as to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the school wide plan, and the school-parent compact.

Cartersville Elementary School will hold an Annual Title 1 meeting on October 24, 2024. Information regarding this meeting will be distributed to parents through the form of: take home flyers, social media posts, phone calls and school sign. The CES staff will also produce short video's inviting families to attend the Annual Title 1 meeting.

COMMUNICATIONS

Cartersville Elementary School will take the following actions to provide parents of participating children the following:

- Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parent and family engagement.
- Information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand:

Cartersville Elementary School will provide information about school activities through newsletters, the school website, Blackboard Messenger, the school marquee, and invitations sent home with students. When possible, information is provided in English and Spanish. Interpreters are available to assist when needed in parent programs and conferences.

SCHOOL-PARENT COMPACT

Cartersville Elementary School outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high standards.

Teachers, students, and parents are given different opportunities to participate in school-based decisions resulting in the revision of the compact. RESERVATION OF FUNDS

Cartersville Elementary School will take the following actions to involve parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent by soliciting input at parent open discussion meetings, annual surveys, and CLIP meetings. Comments from these meetings as well as other parent suggestions during the school year will be reviewed and taken into consideration for changes to the family engagement budget.

The Title 1 schools in the Cartersville City School District implement a school-wide program. The school-wide option enables schools to integrate programs, strategies and resources to support high-quality education for ALL students.

COORDINATION OF SERVICES

Cartersville Elementary School, to the extent feasible and appropriate, will coordinate and integrate parent and family engagement programs and activities with other Federal, State, and local programs. CES will provide parent resource support services, that encourage and support parents in more fully participating in the education of their children. CES will utilize and encourage certain programs such to include: ESOL, EIP, Etowah Area Consolidated Housing Authority, Special Education Department (SPED), Social Workers, School Counselors, Mentors, RTI/MTSS specialists, etc., which support parents in more fully participating in the education of their children by planning activities that address identified needs.

BUILDING CAPACITY OF PARENTS

Cartersville Elementary School will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and
- Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement
- Providing assistance to parents of participating children, as appropriate, in understanding topics such as the following:
 - The challenging State's academic standards
 - The State and local academic assessments including alternate assessments
 - The requirements of Title I, Part A
 - How to monitor their child's progress
 - How to work with educators to improve the achievement of their child
- Cartersville Elementary School will utilize online resources to provide parents with handouts concerning great educational websites to provide extra assistance with helping their children reach high academic goals.

BUILDING CAPACITY OF SCHOOL STAFF

Cartersville Elementary School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents. The training will concentrate on how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- Utilizing the Technology Specialist to implement trainings on effective communication with parents.
- Providing training on how to access resources for interpretation and translation assistance in providing communication in a family member's understandable language. Staff can request multiple support resources: video remote interpreter, an on-site interpreter, telephone interpretation, and document translations.
